

POLICE COMMISSIONER PROMOTES INVESTMENT IN YOUTH

WA Police Commissioner Karl O'Callaghan gave an inspiring address recently in Bunbury on the importance of supporting young people to reach their full potential.

The Commissioner spoke of the need to keep young people out of the criminal justice system.

He called for the community to invest in young people and parenting supports. The Commissioner referenced the work of Police and Citizens Youth Clubs (PCYC). Although manned by police, like many organisations the PCYC require community support to operate effectively. BE ALCOHOL AWARE

The Be Alcohol Aware project aims to utilise the skills of young people to promote responsibility in the use of alcohol. Schools and youth groups are encouraged to apply for funds to carry out community activities that involve young people in promoting alcohol awareness.

Three 'Be Alcohol Aware' community activities have been recently funded and more are awaiting approval. Collie Senior High School will work with approximately 200 year 8 and 9 students in 2011. The awareness raising will be as hands on as possible, with students given the opportunity to

measure standard drinks and develop possible scenarios and role-plays.

The South West Aboriginal Medical Service will work with a group of young women between the ages of 12 and 15 to create culturally appropriate posters to distribute to community agencies frequented by Aboriginal people such as SWAMS (medical clinic), and ACES (employment service). These young people hope that their posters will encourage not only the young people in the community but also the adults to become more 'alcohol aware'.

The City of Bunbury will support rescheduling of GWN television advertisements promoting responsibility around supply of alcohol to minors. The genesis of this idea was approved by the City of Bunbury Youth Advisory Committee. YOUTH ISSUES IDENTIFIED

Based on 192 responses to a survey of youth workers and young people across Australia conducted by the Australian Youth Affairs Coalition in 2010, a priorities list has been released of the top 5 youth issues, and top 5 youth sector requirements.

Top 5 youth issues:

1. Mental health
2. Education and training
3. Drug and alcohol consumption
4. Participation in the community
5. Employment

Top 5 youth sector requirements:

1. Funding requirements
2. Organisational sustainability
3. Partnership building
4. Policy consultation
5. Communication with government

STRUCTURAL REVIEW FOR REGIONAL DEVELOPMENT COMMISSIONS

In July 2010 Investing In Our Youth was one of many organisations that responded to a call for comment on proposed changes to the structure of regional development commissions. Responses reflected local confidence in the SWDC and satisfaction with the service provided, reinforcing the effectiveness and efficiency of the current structure of regional development commissions.

Investing In Our Youth supports the commonly held view in the SW that regions are unique and have diverse needs and that development commissions require a structure that allows them the independence to quickly and flexibly respond to emerging community needs.

A report has recently been released recommending a change in structure and governance.

The new structure calls for amendments to the Regional Development Commissions Act. Regional development commissions would come under one entity – the WA Regional Development Council. RDCs would no longer be individual statutory authorities, but would form part of the WA statutory authority. This authority would report directly to the Minister for Regional Development and provide general managerial and administration oversight to the regional offices.

The authority would endorse appointment and deployment of staff; be responsible for strategic financial resource management; endorse strategic, business and operational plans; and conduct peer assessment and evaluation. This change is anticipated to lead to reduced autonomy for regional development commissions.

EARLY YEARS COLLABORATIVE PROJECT

Investing In Our Youth has taken up an opportunity to work with the newly formed Community Services Leadership Group focusing on promoting early year's collaboration. The committee, convened by the Department of Premier and Cabinet, involves government and not for profit representatives in exploring ways to work collaboratively to demonstrate improvements in the wellbeing of children in WA.



STATE GOVERNMENT SHARPEN FOCUS ON EARLY CHILDHOOD

Using advocacy strategies such as letters to Ministers, a community 'postcard' addressed to politicians and policy makers, and submissions to parliament, Investing In Our Youth have been calling for increased financial commitment from the Government in the area of prevention and intervention in the early years of life.

Investing in Our Youth is heartened by recent commitment from the State government to provide funding in the next State budget for new early years facilities and services. Premier Barnett has been quoted as saying that he thinks it is important to invest in pre-school education, playgroups, and childcare, three year old kindergarten...health services for young mothers, parenting services and even justice services.

This sounds like a positive development and one that will be followed with interest by early year's champions such as Prof Fiona Stanley and WA Commissioner for Children and Young People Michelle Scott.
